### **JOB SUMMARY**

Performs a variety of unskilled or semi-skilled maintenance work, and operates a variety of equipment on the construction, operation, repair, maintenance, and replacement of City Street and storm drainage facilities and system.

### **ESSENTIAL FUNCTIONS**

Ensures the proper maintenance of equipment and tools by cleaning and checking equipment and tools after use.

Drives trucks of various sizes and weights in the loading, hauling and unloading of various equipment, gravel and sand.

Performs routine inspection and preventive maintenance on assigned equipment and refers defects or needed repairs to supervisor; cleans equipment.

Performs all duties in conformance to appropriate OSHA standards.

Performs required labor involved in construction and maintenance projects as part of crew, including cutting grass, edging, weed eating, blowing, pavement cutting, ditch digging, manhole and catch basing cleaning, main and pipe repair, laying and backfilling.

Operates a variety of power construction and maintenance equipment used in street maintenance and repair.

Performs other related duties as assigned.

### **MINIMUM QUALIFICATIONS**

High School Diploma or GED OR any equivalent combination of education, training, and experience which provides the requisite knowledge skills and abilities for the job.

### **LICENSES AND CERTIFICATIONS**

Must possess and maintain a valid driver's license and CDL or ability to obtain one.

## PHYSICAL DEMANDS

Regularly required to use hands to handle, feel or operate objects, tools or controls and reach with hands and arms. Frequently required to stand and talk or hear. Occasionally required to walk, sit, climb, or balance, stoop, kneel, crouch, or crawl and smell. Frequently lift and/or move up to twenty-five (25) pounds and occasionally in and/or move up to one hundred (100) pounds.

Specific vision abilities required by this job include close vision, distance vision, color vision, peripheral vision, depth perception and the ability to adjust focus.

## WORK ENVIRONMENT

Regularly work in outdoor weather conditions. Frequently work near moving mechanical parts and is frequently exposed to wet and/or humid conditions and vibration. Occasionally work in high, precarious places and is occasionally exposed to fumes or airborne particles, toxic or caustic chemicals and risk of electrical shock.

The noise level in the work environment is usually moderate to loud.
