- B. License Hearing-Afro Caribbean Restaurant

After numerous noise complaints on the above business, a hearing concerning the privilege license has been scheduled in front of Mayor & Council. Letter to the owner/license holder is attached. Mr. Green turned it over to our city attorney for a public hearing. Mr. Kimbrough asked everyone wanting to speak to stand & he swore them in. The following complainants spoke regarding the noise & nuisance violations coming from King Caribbean Restaurant: Randall Adams, George Kosha & wife Mrs. Davis, Patricia Sawyer, Beatrice Neaseman, Frank Sessness, & Liza Keno. The complainants are requesting for something to be done to control the noise from the music & the people partying in the back of the restaurant. The owner of King Caribbean, Mr. Ojongmgoh,, stated they were just made aware of the complaints several weeks ago. The attorney representing King Caribbean, Mr. William Tiku, stated they are willing to take steps to help this issues & resolve the problems if given the opportunity. Mayor Clemons stated that they were made aware of the complaints almost a year ago while in a meeting with El Galaxy & King Caribbean. He also stated he wanted the neighborhood to know that there have been conversations in the past about the noise complaints.

Mr. Green followed the recommendation of Mr. Kimbrough to close the public hearing. Seconded by Mr. Myrick. Motion passed. (6-0)

Mr. Green made the recommendation to a 30 day business license suspension as of July 12, 2021, must install a sound barrier, install an alarm on the back door for emergency use only, and there must be an inspection done by the building inspector, fire marshal, & code enforcement prior to opening up after the 30-day suspension. Once the restaurant has passed all the necessary inspections, they will be allowed to reopen. At the time of reopening, they will be on a 90-day probation period. If the City of Austell or Cobb County receives 2 or more complaints, the business license will be revoked indefinitely. Seconded by Mr. Myrick. Motion passed. (4-2)

Could not meet specification and sent a letter of no bid.

The City of Austell Fire department is recommending the purchase of a new Aerial Mid Mount Platform. After consideration of companies that submitted proposals, the fire department is requesting the purchase of a 2022 Pierce Velocity Mid Mount Platform. We are requesting the purchase of a Pierce for several reasons that include; primarily, due to the size of our engine bay at both stations, Pierce is the only supplier that met the size parameters that are needed to allow us to house this equipment at either station without having to modify the buildings, the last two pumpers that we have purchased are Pierce and we have received good service from them, with the fleet being the same manufacturer, it makes operating and training on the equipment easier. Maintenance is easier, ordering parts would be from the same company, they have multiple mobile service trucks in our area, and we are familiar with the company. We feel that they build very dependable equipment and they have been building fire apparatus for 80 years.

Funding will come from the 2022 SPLOST and 2011 SPLOST.
