A. Caleb's Way Sidewalk & Resurface Project

It is the recommendation of Public Works Department to accept and approve the bidding of PKS Paving & Concrete Construction, as the lowest bidder in the amount of \$57,920 for the Caleb's Way.

This project will include:

- Light Grading
- Concrete sidewalk 5'x 640' x 4", and 3 driveway aprons 10'x12'

• Roadway 17'x 640'x 2.5" overlay

The funds for this project will come from 2016 SPLOST.

Mrs. Anderson made a motion to approve the Caleb's Way Sidewalk & Resurface Project. Seconded by Mr. Thomas. Motion passed (5-0).

B. Fleet Trucks

It is the recommendation of Public Works Department to accept and approve vehicles to add on to the fleet department. The total is \$132,231.00 for 5 vehicles.

- (1) One 2019 GMC Canyon SLE Gas V6 4WD \$30,741.00
- (1) One 2019 New Body Style Crew Cab 4WD V8 \$28,578.00
- (3) Three 2019 New Body Style Double Cab 2WD V6 \$22,713.00 each

The funds will come from 2016 SPLOST. Mrs. Anderson asked Mr. Garrison what will be done with the old trucks that these will be replacing. Mr. Garrison stated the old trucks cost too much to repair and will be sold as surplus.

Mrs. Anderson made a motion to approve the purchase of 5 vehicles. Seconded by *Mrs.* Leverette. Motion passed (5-0).

12. PARKS DEPARTMENT SCOTT THOMAS, CHAIRPERSON Jim Graham, Director

A. Parks Equipment

The Parks Committee recommends approval for the purchase of a 2019 Chevrolet Silverado 3500HD 2WD Regular Cab in the amount of \$26,827.00.

We also would like to secure an additional \$9,000 for a box truck to be used by Parks. Due to the age of the one that is being used now it is in need of a costly amount of repairs. The money will come from 2016 SPLOST funds.

Mr. Thomas made a motion to approve the purchase of a new truck for the Parks Department. Seconded by Mrs. Anderson. Motion passed (5-0).

B. Fountain Renovation

The Parks Committee recommends approval for the renovation of the fountains in front of the Threadmill. The renovations will consist of totally re-doing all three fountains. They will have new paint, plumbing lines and LED lights. Please see attached specification sheet for the entire scope of work. Mr. Council Minutes 10/1/18

Thomas asked Mr. Graham what all will be done to the fountains. Mr. Graham stated they will have new paint, new plumbing lines and 4 LED lights in all the fountains to light up at night. They will have stacked stone on the outside of the fountains. Renovations will start by the end of October or first of November.

The total for this renovation will be \$173,200.00 and will be paid for by 2016 SPLOST funds.

Mr. Thomas made a motion to approve the fountain renovations. Seconded by Mrs. Leverette. Motion passed (5-0).
