C. <u>Variance Request – Server Permit</u>

City Attorney Hylton Dupree asked Ms. Ashlyn Osborne to come forward. Mr. Dupree stated that we did your background check & it indicated you had an arrest back in 2015. Ms. Osborne said yes. Mr. Dupree asked Ms. Osborne to tell us what that was about. Ms. Osborne stated she was in Gwinnett County and went out that night and ended up getting pulled over. There was a bottle of alcohol in the car and I was also under age at the time, so I got charged with both of those. That was my one and only time of getting in trouble. Mr. Dupree stated you originally had a conditional discharge is that correct? Ms. Osborne stated yes that was correct. Mr. Dupree stated you were later sentenced to probation for 12 months? Ms. Osborne stated yes. Mr. Dupree

asked if that was the only charge you have ever had? Ms. Osborne stated yes. Mr. Dupree asked at this particular job you will be serving alcohol? Ms. Osborne stated yes. Mr. Dupree asked if there were any further questions. Ms. Leverette asked Ms. Osborne where will you be working. She stated she will be working at La Salsa. Chief Starrett asked if she had had any trouble since that time. She stated no she had not. Mr. Dupree stated in the ordinance, any conviction within 10 years may be a bar to issuing a servers permit, however you do have the right to reconsider it based on the information you received tonight. Mr. Green stated he knows the applicant personally and he thinks this is a onetime incident with her.

D. Metal Detector

Mr. Green asked Chief Starrett to explain about the metal detectors. Chief Starrett stated there has been discussion about having the metal detectors at council meetings. We have had certain things come up in our department and also the Gas Company. We want to purchase the metal detectors you walk through, I told the Council and they were in favor of it. If we purchase 2 of them we get a special rate. We will have it at the door to utilize for Council meetings for people to walk through and we will have an officer there to check people. Most of the other Councils have it at their meetings. The cost would be \$3,200.00 each there may be shipping or may not be.

B. <u>O Spring Street Annexation/Rezoning</u>

The Department of Community Affairs has received a request from Trina Johnson to annex and rezone the property located at 0 Spring Street in LL 205, parcel 24 of the 182 District of Douglas County, from Agricultural to Neighborhood Shopping (NS). The proposed use of the property will be assemblage for a new Day Care/Pre-School.

The Planning and Zoning Board voted 6-0 in favor of the proposed annexation and rezoning. We now need to have 2 public hearings, the first will be the rezoning followed by the annexation. Mr. Clemons turned it over to our City Attorney Hylton Dupree.

Mr. Dupree asked Ms. Trina Johnson to come up. Mr. Dupree swore Ms. Johnson in. Mr. Dupree asked that she was seeking the rezoning of this property for the use of a daycare. Ms. Johnson stated yes. Mr. Dupree asked if there was anything she would like to add to the application. Ms. Johnson stated it is 2.61 acres, and most of the acres are in Cobb County, there is a small portion in Douglas and we are trying to annex it all. Mr. Dupree asked what was decided to do with the house that was on the property. Ms. Johnson stated it is being renovated now and we will use it as an office. Mr. Dupree asked if any one signed up in opposition. No one opposed.

Mr. Ollie Clemons made a motion to close the Public Hearing. Seconded by Randy Green. (6-0)

Mr. Ollie Clemons made a motion to approve the rezoning of the property located at 0 Spring Street, LL 205 parcel 24 of the 182 District of Douglas County from Agricultural to Neighborhood Shopping. Seconded by Randy Green. (6-0)

Mr. Clemons stated he would turn it over to our City Attorney Hylton Dupree for our 2nd public hearing. Mr. Dupree stated a portion of the property is in Cobb and a portion is in Douglas County. Ms. Johnson stated yes. He asked that she wanted it all in Cobb in the City of Austell and she stated yes. The Mayor stated that we cannot change the Douglas County part but we can put it inside the City of Austell. Mr. Dupree stated it will still be partially in both counties. Mr. Jim Graham stated Douglas County is not in opposition, they already thought it was in the city.

Mr. Ollie Clemons made a motion to close the public hearing. Seconded by Ms. Valerie Anderson. Motion passed (6-0).

Mr. Ollie Clemons made a motion to approve the annexation for the same property. Seconded by Randy Green. Motion passed (6-0).
